Category 8: Producer of the Year – Eligible entrants, whether an individual or a production team, must have produced or co-produced at least five recorded songs on product eligible in the current year’s Album of the Year categories, other than those on which said entrant was the artist. To qualify as a production team, the total number of Recorded Songs produced by each individual member of the team, whether produced in whole or in part, must be less than the total number produced by the team. In other words, no member of a production team may have produced more Recorded Songs individually (or as part of another team) than the production team being entered below.

For each entrant you must list five Recorded Songs (including the artist, album, label and release date) produced or co-produced by the entrant on product eligible in the current years Album of the Year categories, other than those on which said entrant was the artist. An album produced or co-produced entirely by the entrant, and eligible in the current year’s Album of the year categories, may substitute for the five Recorded Songs as long as the artist, label and release date is also listed.

Category 34 Choral Collection of the Year: This category awards the actual collection, not the accompanying album. Music arranged for choir in multiple parts cannot contain story line.

Category 35 Spoken Word recording of the Year: This category awards the actual speaker. The Production Company/Record Company may purchase an additional Unity Award for their recipient recording.
